- В. COURSE DESCRIPTION: This course is a continuation of ASL 1107. The course will build upon vocabulary and grammar, history of ASL and the Deaf/deaf community, and Deaf Culture aspects. The course is designed to encourage students to communicate in the target language learned in level 1 in an abstract and conceptual thought process in and out of the classroom environment. Students will learn and demonstrate the ability to converse on various topics, past, present and future. Students will also learn and demonstrate appropriate deaf culture norms (directing and maintaining attention and when communicating in ASL; keeping others informed; and following cultural conversation norms in the deaf community.
