

Course discipline/number/title: HS 1770: Alcohol and Drug Counseling Practicum I

A. CATALOG DESCRIPTION

1. Credits: 3
2. Hours/Week: 440 hours arranged over the course of the semester offsite. 1-hr. weekly seminar.
3. Prerequisites (Course discipline/number): HS 1710 and HS 1750
4. Other requirements: Admission to the RCTC Alcohol and Drug Counseling Program or Certificate

B. COURSE DESCRIPTION: Students in Practicum I will demonstrate their mastery of academic coursework in the 12-core functions of an alcohol and drug counselor, while completing a minimum of 440 hours of clinical practice under the supervision of a Licensed Alcohol and Drug Counselor, or other qualified professional. During regularly scheduled seminar meetings students will discuss ethical and professional considerations, boundary setting, interpersonal conflicts, and their engagement in the therapeutic process. Furthermore, students will share with one another their practicum experiences, challenges, successes, areas for improvement, and progress in the twelve core functions. Admission to the RCTC Alcohol and Drug Counseling Program or Certificate.
