- B. COURSE DESCRIPTION: This course will give the student who has completed NA 1500 theory and clinical or an equivalent course, the knowledge, and skills necessary for employment in a hospital or other acute care setting. The student will receive classroom and lab/clinical training which will help them prepare to care for the acutely ill or chronically ill patient. Clinical experience in the hospital setting will be provided. This course may be taken concurrently with HCOP 1610, ENGL 1117, PSYC 1611 or PSYC 2618 for those students that are pursuing completing the Advance Hospital Nursing Assistant Certificate.
